THE MINISTER OF FINANCE (SHRI PRANAB MUKHERJEE): (a) and (b) Yes, Sir.

(c) During the meeting of the Aid India Consortium in Paris on June 14-15, 1982, there was wide appreciation of the growth performance of the Indian economy in 1981-82. It was noted that India had controlled inflation while maintaining a high rate of growth. There was a general consensus on the need for increased flow of concessional assistance to India especially in view of its difficult balance of payments situation. Indications of commitments to be made by individual countries and the World Bank amounted to dollars 3.66 billion. The Consortium assistance is used for financing developmental projects included in the Plan. The outcome of the Consortium meeting is regarded as generally satisfactory.

(d) In consultation with other developing and donor countries, Government are taking steps to try and maintain the commitment authority of IDA at originally planned levels.
