Frequent-Traveller schemes on Shatabdi trains

- 1910. SHRI RAJEEV SHUKLA: Will the Minister of RAILWAYS be pleased to state:
- (a) whether Government have any plans to introduce frequent traveller benefit schemes on short-distance trains like Shatabdi trains; and
 - (b) if so, the details of the porposal in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI R. VELU): (a) and (b) With a view to improve the patronisation of higher classes, where occupancy level is relatively low as compared to that in Sleeper class and 3-AC classes, a Scheme of Frequent Travellers (SOFT) has been launched in the month of February, 2006, which is applicable to 1stAC, 2AC and AC Chair Car Classes. A Frequent Traveller will get a complimentary train trip after certain numbers of reward points are accumulated.

Escalator facility at Madurai

Will the Minister of RAILWAYS be pleased to state:

- (a) whether it is proposed to set up escalator facility at Madurai railway station; and
 - (b) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI R. VELU): (a) and (b) There is a proposal for provision of escalator facility at Madurai Junction railway station and the same would be considered alongwith other works subject to availability of funds, etc.

Bijapur-Yeshwanthpur-Basava Express

- (a) whether it is a fact that Bijapur-Yeshwanthpur-Basava Express has started operating on daily basis instead of thrice in week;

- (c) if not, the reasons for not operating the Bijapur-Yeshwanthpur-Basava Express on daily basis even after the long pending demand from public and the Members of Parliament and other representative from this area; and
 - (d) the date from which the train would operate on daily basis?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI R. VELU): (a) No, Sir.

- (b) Does not arise.
- (c) Due to operational and resource constraints.
- (d) At present, there is no proposal to increase the frequency of the train to daily.

New railway projects in North Eastern Region

- (a) the details of new railways projects in the country particularly in the North Eastern Region that have been formulated during the current year;
 - (b) the total funds allocated on the these projects; and

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI R. VELU): (a) to (c) No new project in the North Eastern Region has been included in the Budget 2006-07. However, two new line proposals from Dimapur to Kohima (Zubza) and Azra-Byrnihat have been processed for necessary approvals.
