The Chief Minister of Rajasthan has intimated that effective steps are being taken to ensure the proper enforcement of ban on cow slaughter. The Governor of Assam has informed that field Officers are being instructed to exercise greater vigilance in ensuring strict enforcement of the legal provisions relating to ban on slaughter of cattle.

The State Governments of Uttar Pradesh and Orissa have been reminded to intimate the steps taken.

- (a) the number of persons who offered to export onions through NAFED during the last three years: and

THE MINISTER OF AGRICULTURE AND RURAL DEVELOPMENT AND CTVIL SUPPLIES (RAO BIRENDRA SINGH): (a) The number of Associate Shippers registered with NAFED for export of onion from the country during the last 3 years, was as follows: —

- (i) 1979-80—338
- (ii) 1980-81-³³
- (iii) 1981-82-496

(b) As export of onion is canalised through NAFED, the Associate Shippers who want to export onions have to approach NAFED and not the Government. The question of Government taking a decision in regard to the export of onion by various exporters does not, therefore arise.
