THE MINISTER OF STATE IN THE MINISTRIES OF EDUCATION AND CULTURE AND SOCIAL WELFARE (SHRIMATI SHEILA KAUL): According to the decision of the Delhi University, candidates who have passed their Bachelors' degree Examination under 10+2+3 scheme of education or an examination recognised as equivalent thereto, will be eligible for registration to the post-graduate courses, i.e., MA/MSc/M Com. with effect from the current academic year. The University has also decided that students who have received 15 years of formal education i.e., pass in the examination from a statutory body within the prescribed duration of course(s), shall also be eligible for admission to post-graduate courses of the University.

Students Grievance Committee

2930. SHRI N. P. CHENGALRAYA NAIDU: Will the Minister of EDUCATION be pleased to state:

(a) whether it is a fact that the Executive Council of Delhi University and recently decided to set up a students' grievance committee in response to the long standing demand of the students of the University;

(b) if so, what will be the main functions of the committee;

(c) the names of members of the Committee; and

(d) the number of complaints which have so far been received by the Committee and the action taken on those complaints so far?

THE MINISTER OF STATE IN THE MINISTRIES OF EDUCATION AND CULTURE AND SOCIAL WELFARE (SHRIMATI SHEILA KAUL):

FARE (SHRIMATI SHEILA KAUL): (a) Yes, Sir. The Delhi University has decided, in principle to set up a Students' Grievances Committee.

(b) According to the decision taken by the University, grievances of College students should first be considered by the Joint Teachers and Students Consultative Committee at the College level. In case the student concerned is not satisfied with the decision of the College level Committee, and if his grievance relates to any alleged violation of the provisions of the University Act, Statutes and Ordinances, the matter could be considered by the Grievances Committee on receipt of a specific request from him. The Committee will, however, not consider any grievances relating to disciplinary cases, matter of confidential or secret nature, and cases involving use of unfair means at the University Examinations.

(c) and (d) The composition of the Committee has not yet been decided, and the Committee has not started functioning.

Historical Monuments in Chitradurga

2931. SHRI H. HANUMANTHAPPA: Will the Minister of EDUCATION be pleased to state:

(a) the details of the historical monuments listed in Chitradurga District of Karnataka; and

(b) the details of the schemes to maintain these monuments?

THE DEPUTY MINISTER IN THE MINISTRIES OF EDUCATION AND CULTURE AND SOCIAL WELFARE (SHRI P. K. THUNGON): (a) The centrally-protected historical monuments in Chitradurga District of Karnataka are: Asoka inscriptions at Brahmagiri; Fortress and temples on the hill at Chitaldrug; Hariharesvara temple at Harihar; Inscription and Jatingi Rameswar temple on Jatingi Ramesvara Hill;

and Akkatangi temple and Asoka inscriptions on Emmethammananagundu at Siddapur.

(b) The monuments are being maintained as per the actual needs. During the current financial year provisions have been made for special repairs to the Fortress at Chitaldrug and Hariharesvara temple at Harihar.

Functioning of National Library

(a) whether attention of Government has been drawn to a news

item entitled 'books on national library floor' in the 'Statesman' of 3rd July, 1982.

(b) if so, what steps have been taken to make adequate arrangement for keeping the books; and

(c) what are the details of the plans to improve the functioning of the Library in order to enable the scholars and research students to make full use of the Library?

THE MINISTER OF STATE IN THE MINISTRIES OF EDUCATION AND CULTURE AND SOCIAL WELFARE (SHRIMATI SHEILA KAUL): (a) Yes, Sir.

(b) The Government is fully aware of the problem of shortage of space in the National Library, Calcutta and have already drawn up plans for the construction of a new annexe building for the Library during 6th Five Year Plan. However, to meet the immediate need of the Library it has been decided to construct a 2 or 3 storeyed building in the first phase of the proposed new annexe building. Additional shelving space is also being provided by making suitable additions and alterations in the existing accommodation available in the Library which will yield space for one lakh books.

(c) The existing facilities for the scholars and research students at the Library are satisfactory.
