Government paper. Our well-known position is that juridically the areas of Gilgit Hunza and Skardu in Pakistan occupied Kashmir are parts of the Indian State of Jammu & Kashmir. It is the Government's policy to resolve the matter with Pakistan peacefully in accordance with the Simla Agreement.

Speech in Hindi by the Prime Minister in U.S.A.

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO): (a) and (b) In addressing meetings of the Indian communities in Washington, in New York and Los Angeles, the Prime Minister spoke in Hindi in addition to English.

Deportation/Extradition of "Tamil Tigers"

2949. SHRI SURENDRA MOHAN: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether Government have received any request from Sri Lanka for the deportation/extradition of persons belonging to the terrorist group "Tamil Tigers" who are reported to have taken refuge in India;
- (b) if so, whether their presence in India has been confirmed and whether they have been taken into custody;

- (c) whether Government propose to comply with the request of Sri Lanka Government; and
- (d) whether these persons are Sri Lanka citizens or Stateless persons of Indian origin?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO): (a) to (c) Government have not received any request for extradition from the Government of Sri Lanka in the case involving arrest of members of the Sri Lanka Tiger Movement in Madras city in-May and June, 1982. Officials of the two Government have, however, been in touch with each other. Cases have been registered against the arrested persons by the Tamil Nadu Police under Section 307 of IPC for attempt to murder and under the Arms Act for illegal possession of arms.

(d) All the 6 persons taken into custody are Sri Lankan nationals.

Non-vacation of House by Portugal Ambassador in India
