Rial way accidents

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIA-MENTARY AFFAIRS (SHRI MALLI-KARJUN): (a) 203 train accidents and 27 train robberies (other than dacoities) occurred during the last <Kree months, namely, April to June, 1982V

- (b) In these train accidents 67 persons were killed and the cost of damage to railway property so far estimated amounts to approximately Rs. 119.1 lakhs.' Loss suffered by passengers in train robberies is not available.
- (c) Steps taken for prevention of aipcident have started yielding results inasmuch as incidence of train accidents during April to June, 1982 was less .than that during t}ie corresponding perJ.dd of the last year. Instructions have been issued for pursuing the safety, measures in all sphere and at all levels to eliminate train accidents.

Sine* prevention of robberies in trains la a state subject, the attention of the eonc&rned State authorities is constantly drawn to it at various

levels. Even the Minister of Railways has also been drawing the attention of the Chief Ministers of U.P., Bihar, West Bengal and Msdhya Pradesh and Maharashtra towards the need improving security measures on the railways so that better security snd safety could be ensured to passengers.

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLI-KARJUN): (a) Yes, some trains do run late sometimes on account of alarm chain pulling, miscreant activities, disconnection of hosepipes, dents, rolling stock failures, signal failures/defects an,1 other open-ting failures.

(b) Punctuality performance of important mail/express trains is watched in the Railway Board's Office On day-to-day basis. General Managers are paying personal attention to matters pertaining to punctual running of trains. Liaison with concerned State Governments is being maintained by various Zonal Railways for arresting the incidence of alarm chain pulling, hosepipe disconnection and other miscreant activities.

Dislocation of suburban Railway services in Bombay and Calcutta
