THE MINISTER OF STATE IN THE DEPARTMENTS OF SCIENCE AND TECHNOLOGY, ELECTRONICS AND ENVIRONMENT AND OCEAN DEVELOPMENT (SHRI CHANDRA PRATAP NARAIN SINGH): (a) Yes, Sir.

(b) The major snags encountered by the spacecraft related to the deployment of C-band antenna and the solar sail certain anomalies were also noticed concerning performance/operation of telecom transponder channel number five, Data Relay Transponder (DRT), Very High Resolution Radiometer (VHRR) Transmitter, etc. Through a contingency manoeuvre involving a single 60-milli-second firing of a east face thruster below, the stowed reflector, the C-band antenna was successfully deployed. telecom transponder channel number five has also been successfully switched to its telecom mode and as such, all twelve telecom transponder channels are now working. The Data Relay Transponder (DRT) anomaly which was due to incorrect interpretation of test data has been resolved. The final confirmation of the resolution of the DRT anomaly awaits link testing in Data Collection Platform (DCP) burst mode with a DCP data receiver of India Meteorological Department. The operation of the VHRR transmitter is being carefully monitored, and the anomaly has not repeated for the last 15 days. The solar sail is still undeployed.

The launch of the second INSAT-I spacecraft (INSAT-IB) is scheduled, per original plans, in July, 1983. The INSAT-IB was conceived as an tive on-orbit spare satellite. However, as a consequence of the reduced life of INSAT-1A. INSAT-IB is now expected to perform the functions INSAT-IA which after IB launch will become the spare. The question of what other steps are to be taken in the context of the reduction in the life of INSAT-IA are under detailed consideration.
