## Mafia activities by BCCL officials

- 886. SHRI SUKOMAL SEN; Will the Minister of ENERGY be pleased to state:
- (a) whether Government are aware of the involvement of some Bharai Coking Coal Limited officials in mafia activities in the Dhanbad-Jharia coalbelt; and
- (b) if so, what steps have been taken by Government to minimise the involvement of officials in the said activities and with what results?

THE MINISTER OF STATE IN THE DEPARTMENT OF COAL IN THE MINISTRY OF ENERGY (SHRI GARGI SHANKAR MISHRA); (a) and (b) The police authorities at Dhanbad had furnished a list of a few cases in which some BCCL employees were also allegedly involved. Out of the 53 employees named by them 23 have been struck off/dimissed from the (rolls of the company and disciplinary action has been initiated in respect of the remaining persons. The coal companies have been advised inter alia to strengthen the vigilance departments, maintain a list of sensitive posts and carry out rotational transfers of incumbents.

## Mafia contractors operating in the Jharia Coalfields

THE MINISTER OF STATE IN THE DEPARTMENT OF COAL IN THE MINISTRY OF ENERGY (SHRI GARGI SHANKAR MISHRA). (a) and (b) Curbing the mafia activities is a law and order subject and, as such, action has to be taken by the State Government. However, in regard to contracts, BCCL has been, inter alia advised to take the following action: -

- (1) departmentalisation of road transport of coal, coke and sand;
- (2) departmentalisation of minor civil works;
- (3) departmentalisation of major civil works to the extent possible; and
- (4) departmentalisation of certain underground works.
- (c) As a result of the action taken on the above lines, BCCL has already purchased about 440 tippers far departmentalisation of road transport and this work has been fully completed in 50 collieries. Contractors are being eliminated from minor civil works and a departmental nucleus staff for this purpose has been created. Major civil construction jobs are being entrusted to State/Central Government agencies and public sector undertakings. contracts are being awarded to private contractors after verification by the Vigilance Department of the Company.
