This report is under examination.

Shifting of ONGC Headquarters from Dehradun to an Oil Producing Area

907. SHRI VITHALBHAI MOTIRAM PATEL: Will the Minister of PETROLEUM, CHEMICALS AND FERTILIZERS be pleased to state:

(a) whether it is a fact that the headquarters of Oil and Natural Gas Commission is located in Dehradun even though no drop of crude oil is produced in that area; and

(b) whether Government will agree to shift the headquarters of Oil and Natural Gas Commission to an oil producing area in Gujarat or Assam if a demand to this effect is made?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI P. SHIV SHANKAR): (a) Yes, Sir.

(b) The Oil and Natural Gas Commission Headquarters need not necessarily be in an oil producing area. Regional Headquarters with adequate delegated powers exist in oil producing regions to take care of day to day problems for the control/management of the projects. 799 RS—5.
