SHRi DINESH GOSWAMI: Sir, ...

MR. CHAIRMAN: May I tell you what the trouble is? There was a newspaper item that cars were lying unused. Have you seen the word '•imported" in part (a) of the question? They are al¹. probably, locally manufactured which are rotting there, ag you gay. If you had ^{no}t used the word "imported", the question would have been different.

SHRI DINESH GOSWAMI: Sir, have you ever seen Members not creating any trouble like this?

Improvement in the situation in Punjab after ban on Dai Khalsa

•205. SHRI N. P. CHENGALRAYA NAIDU: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that the situation in Punjab has improved after banning the Dal Khalsa and KhaHstan Council;

(b) if so, whether all the persons connected with the KhaUstan movement have been arrested, and what is the number of arrests made so far; and

(c) what steps are being taken to curb the activities of these organisations?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI NIHAR RAN JAN LASKAR): (a) Yes, Sir. It ha₉ helped in improving the situation.

(b) and (c) According to information furnished by the State Government about 60 activists of the Kha. listan agitation have been arrested. Efforts are afoot to apprehend other activists and supporters of the organisations. The Government are keeping a close watch over the situation and will be taking appropriate action as may be required under the law.

SHRI PILOO MODY: Now that we have a new President, all these troubles should stop.

SHRi CHENGALRAYA N. Р NAIDU: Sir, in Punjab the Dal Khalsa people were responsible ifor taking away the plan_e an[^] those people are in Pakistan still and they have not been brought here. And there are other people doing the same thingt here in Punjab also. There is no law and order, actually. Every day, even before the temples, w_e gee that cows' heads are put and troubles are started. And we have seen in paper_g reports that Bhindranwale was going in a bus and stopping at bus stops with machine-guns and other things without licences. I do not ^{un}~ derstand why the Government[^]i, not taking action charging them for not having licences. How are getting machine-guns without they licences? What is happening is that the Department which is awaite of all these thing_s closes its eyes.

SHRI R. VENKATARAMAN: Sir, it ia true that in Punjab the activists of the Dal Khalsa movement are engaging themselves in a lot of unlaw, ful activities. We have recently, even three days back, arrested a group of people. Immediately when the arrest takes place. it is converted into a communal tension. They start morchas and then they take recourse to offending the sentiments of the other community, namely, the Hindus, and then a retaliation takes place and it escalates communal passions. Therefore, the Government has to go wary in this matter. We are trying to arrest as many people a_s possible. We have so far arrested 60 people of the Dai Khalsa. The hon. Member himself knows that it was not possible to arrest these people and we have arrested 60 people of the Dal Khalsa. We are proceeding cautiously. We have to see that it is suppressed.

SHRI N. P. CHENGALRAYA NAIDU: Sir, he referred to the fact that recently some people have been arrested for not having licences for small firearms. Though small people with revolvers and other things have been arrested, what about the big people who are using machine-guns? Why can't the Home Ministry ask the State Government to take firm action? Unless the Central Government asks the State Government to take firm action, they will show indifference I ami cent per cent in agreement with him that the minority community feeling, must be respected, but that cannot fee the guise for using machine, guns and other things and murdering! people. That i am bringing to the notice of the Minister. May I ask the Home Minister to take firm action? He has seen in papers reports about people having machine-guns and other things at bus stops. What action fiave they taken?

MR. CHAIRMAN: "What aTSion" has been added, to a lar,ge amount of lecturing.

SHRI N. P. CHENGALRAYA NAIDU: H_e did not reply. That *is* why i had to repeat.

SHRI R. VENKATARAMAN: Mere angler does not produce results.

MR. CHAIRMAN: But you are always very calm.

SHRi R. VENKATARAMAN: Actu. ally the hon. Member knows-I did not want to go into it, but he proda me to go into it—that many of these people are taking shelter in religious institutions, gurudwaras an^ all that. Under the Criminal Procedure Code, if you want to go into a religious place you have first to give a notice and then only go. If the accused or the suspected person_s leave one place and gb to another, what do We find? Therefore, it is not very effective. We try to arrest them as soon as they come out in the open and when they are parading in the streets. Then we are able to arrest them, We do not want to create or escalate communal i tension by going into gurudwarag or places of religious worship and create a problem. Then the remedy will be worse than the disease.

SHRI PILOO MODY: I am surprises that the Home Minister should make that statement.

SHRI R. VENKATARAMAN: I suppose one must be realistic. You know that under the law you can do so many things. But would you like a state of conflagration to be brought about in a State. Would you like escalation of communal passions? We do not want to do that. In fact, we are...

SHRI PILOO MODY: I am in agreement with you. But don't make that statement.

SHRI KHUSHWANT SINGH: Sir, it must be evident from the Home Minister's? reply that movements of the kind that is being sponsored by the Dal Khalsa, have to be met politically. You have to be able to persuade the Sikh masses that it i9 suicidal and that it is in their own interests that they should with themselves disassociate the movements of this kind. But arresting people, banning the movement, shooting them and giving the impression that they are killed in encounters are being totally counter productive. I do not know whether the Home Minister is aware of writings in the Gurmukhl Press by many organisations withi innocuous names which are propagating the same kind of belief that the Dal Khalsa itself is doing. That ia my first question, whether the Home Minister is aware of this.

The second and even more important question is, knowing the pattern of minority politics in the country, that if the parties are in power they become immediately patriotic and nationalistic but as soon as they are out of power they start talking of discrimination and develop fissiparpus tendencies, in view of that, ig there any plan now to resume talks with the Akali leaders, which the Prime Mmister had had some months ago with them? Ig there any time-schedule when she will meet them again?

SHRI R. VENiKATARAMAN: Sir, the hon. Member asked whether Government is aware that the communal passions would not be further inflamed. Well, Government have been following a policy of trying to assuage the feelings of the communities as much as possible. In fact, that i9 why, in spite of some provocative acts, we continue to deal with them in a very mild and conciliatory manner. If, in spite of it, some sections continue to indulge in voilent acts and disruption of law and order situation, then, Government cannot be a silent spectator. It has to take some action, and this is the thing that is being done.

So far as reconciliation is concerned, Sir, the hon. Member is aware that we have constituted the Integration Council in Punjab, and we have brought all the people, the members of the Akali Dal, and every other section, the Hindus, the minorities and everybody together, and the Chief Minister called a meeting. He wanted to see...

SHRI PILOO MODY: Parsis?

MR. CHAIRMAN: Parsis are not included.

SHRI PILOO MODY: They would not succeed.

SHRI R. VENKATARAMAN: In fact, if the parties had been called, it would have been written off even before we had started. We called only the minorities, not the parties, all the sections of the society, the religious minorities and all that. Unfortunately this meeting was boycotted by that community. I would like the hon. Member to use his influence with the community. It is very unfortunate that they did so when the Punjab Chief Minister tried to find some solution to the' problem by discussion, by having a dialogue, with all these people. He called a meeting of the National Integration Council. Yet the community did not attend. Therefore, i they are frustrating every effort to find a harmonious and peaceful solution.

SHRI KHUSHWANT SINGH: Mr. Chairman, I specifically asked the question of resuming the talks with the Akali leaders by the Centre, which the Prime Minister had had some time ago. Thereafter, the Akali leaders have been making loud protestations that the ball is in the court of the Government.

SHRIMATT INDIRA GANDHI: Sir, I had indicated privately and publicly that I was willing to continue the talks. But every now and then we read in the news papers the announcements from the Akali side that the talks are over and that there is no question of talks. So far a_s we are concerned, we are always willing.

MR, CHAIRMAN: Why it is over, I do not know.

SHRI DHARM CHANDER: Is the hon. Minister aware that the Gurmat Camp was held between July, 6 and II in the border town of Poonch and that these extremists visited that camp and raised anti-national slogans there?

SHRI R. VENKATARAMAN: Sir, I did not follow...

MR. CHAIRMAN: I have not been able to follow the question.

SHRI R. VENKATARAMAN: I plead guilty.

MR. CHAIRMAN: But you are not alone. Mr. Dharm Chancer, please repeat your question You can come forward and speak into the mike.

SHRI PILOO MODY: Mr. Sezhiyan has heard it. He can say.

SHRI ERA SEZHIYAN: He wants to know whether the Minister is $awar_e$ that $_{0}n$ July, 6 and 7...

SHRI DHARM CHANDER: From July, 6 ta 11, a Gurmat camp was held in the border town of Poonch at the Nagali Saheb Gurudwara and some extremists visited the camp and raised anti-national and anti-social slogans and indulged in anti-national activities. I would like to know whether the Home Minister is aware of this or not.

SHRI R. VENKATARAMAN: I require notice for this question.

SHRI R. VENKATARAMAN: Sir, Government will not do anything to escalate communal tensions. Therefore, even if the hon. Member says that we must take very firm action against people who are using the temples and the gurudwaras and all that, we are not going to be persuaded to do any such thing. On the contrary, ...

SHRI SADASHIV BAGAITKAR: Why don't you take the help of religious heads to create some sort of a consensus that religious places may not be used for such purposes?

MR. CHAIRMAN: He has not finished.

SHRI R. VENKATARAMAN: We will not_i I will again repeat, Government will not do anything to escalate communal passions and tensions We will try our utmost to bring about a reconciliation between parties $a^{n<*}$ that is why we have constituted this National Integration Council in which all the communities are members and in which we try our best to see that some solution is arrived at with the consent of the parties. This is the line which we will take and we will not be persuaded to take any other line.

MR. CHAIRMAN: Mr. Minister, there is another part of the question. (Interruptions) Where are they getting arms—local or foreign—and are you doing anything about it?

SHRI R. VENKATARAMAN: I will answer it. If we catch hold of them, then we interrogate them and then we get this information.

MR. CHAIRMAN: You are not able to catch them?

SHRI R. VENKATARAMAN: We have not been able to catch them.

MR. CHAIRMAN: From where do you begin?

SHRI B. SATYANARAYAN REKDY: We would like to know whether you are prepared to call a conference of the religious leaders to prevent the use of religious places or places of worship for subversive activities. That is the question.

SHRI R. VENKATARAMAN: And, my answer which you did not...

MR. CHAIRMAN: Mr. Reddy, you are speaking without my permission.

SHRI PIIOO MODY: Anrl he is explaining without your permission'.

MR. CHA'RMAN; Mr. Shahabuddin.

SHRI SYED SHAHABUDDIN: I fully endorse the view of my honourable colleague, Mr. Khushwant Singh, that this problem cannot be met merely by force, it has to be met through political means. I may add to tint Punjab has some thai perhaps economic grievances with regard to its development which need also to be Now my question Is that loDked into. Dal Khalsa and Khalistan Council have come into prominence of late and the people are yet rather confused! about identity of the people involved. the Does the Government have complete information now about the organisational structure of Dal Khalsa and of the Khalistan movement, namely, the names of its office-bearers, the names of the members of its executive committee and of its council. and can the Government assure us that all the leading lights of these movements are among those who have been taken into custody—the figure of 60 that was mentioned? I would also like the Minister to enlighten us whether there is any organic relationship between the Khalistan movement or the Khalistan Council as it has been put in the question, and the Dal Khalsa.

SHRI R. VENKATARAMAN: We have arrested one person, one Mr. Harsimaran Singh, and according to the information obtained by interrogation of this person, it is understood **that** thiii organisation, namely, Dal Khalsa, Khalistan movement, has a

membership of 3000, and it has seven units in Chandigarh, Ropar, Hoshiar-pur, Patiala, Gurdaspur, Kapurthala and Phonta in Himachal Pradesh. And then at this time there is some information that this Harsimaran Singh has been removed from the presidentship and another person, Thekedar Jaswant Singh, has been made the chief pramukh, and the executive of the organisation is being now reorganised by him. Its headquarters is now Guru Nanak Nivas in the premises of the Golden Temple, Amritsar.

SHRI SYED SHAHABUDDIN: Are the organisations identical or is there any linkage between them?

SHRI R. VENKATARAMAN: We cannot say that.

MR. CHAIRMAN: Now, Mr. Rameshwar Singh, I will give you **a** chance, but please be sure, don't start something else.
