(c) and (d) All State Governments with a substantial Scheduled Caste population, including the Government of Andhra Pradesh, have formulated the Special Component Plans for the Scheduled Castes. These plans envisage identification of schemes under the general sectors of development, which would be of benefit to the Scheduled Castes, quantification of funds from all divisible programmes under each sector and determination of specific targets so as to the number of families to be benefited from these programmes. The focus is to bring about the transfer of adequate resources, both financial and physical in favour of Scheduled Castes with a view to enable them to cross the poverty line. Details of schemes are available in the Special Component Plan document of the States.

During 1982-83, an outlay of Rs. 60500 lakhs has been approved for the State Plan of Andhra Pradesh of which an amount of Rs. 2858 lakhs has been provided for Village and Small Industries, Medium and Large Industries and Minerals, the allocation during the same period under this Sector for the Special Component Plan for Scheduled Castes is Rs. 169.70 lakhs.

Setting up industries in West Bengal

1257. SHRI DIPEN GHOSH: Will the Minister of INDUSTRY be pleased to state:

(a) what is the number of proposals for setting up industries, forwarded by the West Bengal Government to the Central Government during the last five years;

- (b) what is the number of proposals accepted by Government; and
- (c) what is the number of proposals rejected by Government with reasons therefor?

THE MINISTER OF INDUSTRY AND STEEL AND MINES (SHRI NARAYAN DATT TIWARI): (a) to (c) 35 applications for grant of letters of intent/industrial licences under Industries (Development and Regulation) Act, 1951 received from West Bengal State Government Undertakings were registered in the Secretariat for Industrial Approvals during the years 1977 to 1981.

Out of the above said 35 applications, 24 applications have been approved and letters of intent issued, while 10 applications have been rejected on various grounds like capacity constraints, scarcity of raw materials, the item of manufacture having been reserved for small scale sector, etc. The remaining one application is still under consideration.
