(b) The estimates show tha\* Indian Ocean nodules cover 10 million sq.

- km. of the seabed. The estimate, of resources ar<sub>e</sub> varying roughly from several hundred million tonnes to several billion tonnes.
- (c) The project is still in the exploratory stage of assessment of the magnitude and density of distribution of nodules in different areas of the Indian Ocean.
- (d) The technology of exploitation of manganese nodules and its economic fasibilry are being worked out.
