However, cooperation in research and development relating to solar energy is being carried out between organisations in India and some foreign countries under the respective Agreements for cooperation in science and technology with these countries. The cooperation is in the form of exchange of scientists, exchange of information and exchange of equipment and prototypes. Among countries with which such arrangements have been worked out are: Australia, Federal Republic of Germany. France, Italy, USA Ü.S.S.R.

## Space programme in collaboration with U.K.
