ble in the near future to extend the STD scheme to Kolaghat which presently is served by a manual exchange and has a small volume of trunk traffic.

# Evasion of licence fee for radios and television sets

1288. SHRI SUKOMAL SEN: Will the Minister of COMMUNICATIONS be pleased to state whether Government are considering some effective ways of preventing evasion of licence fees for radio and television sets?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS (SHRI VIJAY N. PATIL): The existing measures are quite adequate to effectively check the levasion of licence fee on Radio and Television sets. No fresh proposals are, therefore, under consideration.

#### Suspension of members of All India P & T Workers Union

1289. SHRI SUKOMAL SEN: Will the Minister of COMMUNICATIONS be pleased to state:

- (a) whether it is a fact that five members of the All India P&T Workers Union were suspended for demanding bonus for the employees in October, 1980;
- (b) whether bonus has since been sanctioned and paid to the P&T employees; and
- (c) if so, whether Government are considering to revoke the suspension order now and reinstate the Union representatives, and if not, what are the reasons thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS (SHRI VIJAY N. PATIL): (a) No, Sir. Five workers of Telecom. Factory Bombay who are also members of the All India P&T Industrial Workers Union were arrested by the police for indulging in misconduct and unlawful activities in the factory and were placed under suspension in October, 1981.
