In an attempt, to improve operational results, Vayudoot after a survey, has withdrawn its services from discouraging sectors in the North. Eastern Region. Flights to Rupsi and Kamalpur have been withdrawn. The sector Gauhati/Kailashahar has been substituted by Agartala/Kailashahar. And the Gauhati/Shillong flights has been extended to silchar. With the rationalisation of the above routes, the load factor has improved. Similarly, services t<sub>0</sub> Muzaffarpur discontinued due to lack of traffic. Services to other sector<sub>s</sub> ar<sub>e</sub> proving 'to b<sub>e</sub> popular.
