Express was double-headed from 6-5-81 the load of 7/8 Godavari Express was augmented by one second class sleeper coach from 1-7-81. Also one first class coach was replaced by one AC 2 tier on 7/8 Express from 5-6-81. Due to line capacity constraints on sections enroute, it is not feasible to introduce an additional train between Waltair and Hyderabad. However, there is a proposal under examination to increase frequency of 123/ 124 A.P. Express and action as found feasible will be taken.
