Incidence of Sexually Transmitted diseases

1513. SHRI SYED SHAHABUDDIN: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether it is a fact that the incidence of sexually transmitted diseases is on the increase in the country;
- (b) whether it is a fact that 10-20 per cent of the population including teenagers suffer from such diseases; and
- (c) the steps Government propose to take to control its prevalence and to provide treatment?

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (MISS KUMUD BEN M. JOSHI): (a) There is no clear cut evidence to this effect. Due to better treatment facilities provided at over 250 functioning STD clinics, however, larger number of cases are reporting at these clinics.

- (b) There is no reliable statistics warranting the assumption.
- (c) Over 250 STD clinics are providing treatment facilities to the patients. Under the Sixth Plan, the Central Government is providing assistance to the States/Union Territories by way of training in the discipline of venereology, training of medical officers/laboratory technicians/health educators/public health nurses. Research is also being conducted in these diseases.

(b) to (e) The basis and extent of reservations of seats, apart from the reservations for Scheduled Castes and Scheduled Tribes, vary from State to State: Information in this regard is not available with the Government of As per information available with this Ministry four medical colleges in Karnataka are charging capitation fees. In these colleges, 5 per cent seats are reserved for candidates from Karnataka who are admitted on payment of Rs. 60,000, 20 per cent seats are meant for external candidates who are admitted on payment of Rs. 1.60 lakhs and 10 per cent seats are allotted by the management. In addition, three newly set up medical colleges in Karnataka and one newly set up medical college' in Andhra Pradesh are also charging capitation fees.
