taken was conveyed to the Canadian High Commission in New Delhi as also to the Canadian authorities in Ottawa through the Indian High Commissioner. The Canadian authorities have regretted that this incident should have occurred and have agreed to take suitable measures to prevent the recurrence of such incidents.

## Global negotiations on International Economic Order

• (a) whether Government have called upon all the big economic powers of the world for immediate resumption of global negotiations to bring about the much needed new international economic order in the light of the plan enunciated by the French President for bringing about a new world order based on rapid spread of new technologies; and

(b) if so, what is the response of each of the big economic powers to this call?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI Р. NARASIMHA RAO): (a) The Government of India has been consistently supporting the launching of Global Negotiations notably at the Cancun Summit and New Delhi Consultations. India also lent support to the call given b<sub>v</sub> the French President in his address to the Versailles Summit in regard to Global negotiations and technologies.

(b) The seven largest industrialised countries of the world have all accepted at their summit meeting in Versailles in June 1982 that the launching of global negotiations is a major political objective. In this context they have found the latest draft resolution of the Group of 77 helpful and agreed that it could serve as a basis for further consultations. They have also expressed the belief that there are good prospects for the early launching and success of global provided negotiations independence of the Specialised Agencies is preserved.
