**REFERENCE TO THE REPORTED  
NEAR DEAD-LOOK SITUATION EM  
THE RADIO-THEREBY DEPARTMENT  
OF SAFDARJUNG HOSPITAL**

PROF. SOURENDRA BHATTACHARJEE (West Bengal): Mr. Deputy Chairman, Sir, the reported pitiable state of Radiotherapy Department in Safdarjung Hospital cannot cause but great anxiety. I have stated in a report in the Indian Express that owing to dearth of Radiographers who administer the treatment, an expensive and sophisticated machine to X-ray the brain in the Operation Theatre of the Neurology Department and two X-ray units in the Casualty Department are lying idle. One of the two brain X-ray machine bought by Safdarjung Hospital was donated to the AIIMS as it remained

unused at Safdarjung Hospital. Ten Radiographers quit the hospital because of refusal to grant 'radiation allowance' or to improve the pitifully low salary scales for radiographers with inadequate promotional opportunities.

Five out of 20 Radiographers suffered from heart and kidney ailments after 20 years of service. The Radiation Allowance is reported to be paid in other States. The scales for Radiographers obtaining in ALIMs and oilier hospitals are higher. This situa-121j11 in Safdarjung Hospital-is acting U> the detriment 51 serious cancer patients. The Government should take immediate steps to remove the legitimate grievances of Radiographers regarding 'radiation allowances', improve pay scales and greater promotional opportunities, so that the Radiographers are not forced to leave the Hospital and, in the process, serious cancer patients do not suffer.

There were protests in Tamil Nadu and later it attracted the attention of the Prime Minister and because of her intervention, the *status* QUO is restored. . Later it was explained that the I&B. Minister, Mr. Vasant Sathe, did not at all consult the Prime Minister, T do not know wheher in ordering the broadcast of these news items, the hon, Prime Minister has been consulted or not or whether the I. & B. Ministry is acting on its own.
