I shall first put the Motion moved by Shri Bhishma Narain Singh, duly seconded by Shri Kalpnath Rai, to vote.

The question is:

"That Shri Shyam Lal Yadav be chosen as the Deputy Chairman of the Rajya Sabha."

The motion was adopted.

MR. CHAIRMAN: I declare that Shri Shyam Lal Yadav has been chosen as the Deputy Chairman of the Rajya Sabha. (Interruptions).

SHRI PILOO MODY: Mr. Chairman, Sir, this is not the procedure. (*Interruptions*).

MR. CHAIRMAN: I will suggest that the Leader of the House and the leaders of the various groups may say something.

SHRI ERA SEZHIYAN (Tamil Nadu): Sir, the Leader of the House is absent.

MR. CHAIRMAN: Before I call the various leaders, Mr. Piloo Mody, may I say a few words?

SHRI PILOO MODY: Yes, of course. You always take precedence over us.

FELICITATIONS TO THE DEPUTY CHAIRMAN

MR. CHAIRMAN: May I, Mr. Shyam Lal Yadav, welcome you again as the Deputy Chairman of this House? You have been of immense help to me and I hope that you will have just as successful a term as you had before. I am glad to see that in spite of the fact that there was opposition to you, you have been received with open arms by Mr. Piloo Mody. (Interruptions) But you have to be very careful of his bear hug. (Interruptions)

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI A. P. SHARMA): Sir,... (Interruptions)

SHRI PILOO MODY (Gujarat): First from this side.

AN HON. MEMBER: You are not the Leader. (Interruptions) From this side, first, (Interruptions)

SHRI PILOO MODY: It is always our prerogative.

MR. CHAIRMAN: We will ask Mr. Yadav. (Interruptions)

SHRI PILOO MODY: We cannot surrender this prerogative. (Interruptions)

SHRI A. P. SHARMA: I do not think you are going to change the procedure.

MR. CHAIRMAN: This is hardly appoint of order; it is a point of disorder, because I do not know how.

SHRI PILOO MODY: It is not a question of point of order; it is a question of prerogative. It is our prerogative. (Interruptions) Let us do it. (Interruptions)

SHRI A. P. SHARMA: Mr. Shyam Lal Yadav has not only been an important Member of this House but he has a very close association with the politics of the country. Sir, he became Deputy Chairman in 1980 and he performed his duties as Deputy Chairman of the Rajya Sabha efficiently and impartially. Sir, he comes from the biggest and most important State of our country, namely, Uttar Pradesh.... (Interruptions)

SOME HON. MEMBERS: Why? (Interruptions)

SHRI A. P. SHARMA: He was Minister of Parliamentary Affairs, Industry and Labour in Uttar Pradesh. He was General Secretary of the Bharatiya Kranti Dal... (Interruptions) Please sit down. He was General Secretary of the Bharatiya Kranti Dal till such time this party merged with the Indian National Congress. Although, Sir. we will be losing a very important Member and a strong advocate of our party, we are happy that the House will be benefited by his services. (Interruptions) As far as we are concerned, we would like to assure that he will get all possible cooperation...

AN HON. MEMBER: Possible? (Interruptions)

SHRI A. P. SHARMA: All cooperation.

SHRI B. D. KHOBRAGADE (Maharashtra): Every cooperation,

SHRI A. P. SHARMA: Every cooperation in transacting the business of the House will be given by the party and the

Government. Now, Sir, Shri Shyam Lal Yadav does not belong to any side. He belongs to the whole House, and I wish him all success in his office as the Deputy Chairman. (Interruptions)

SHRI PILOO MODY: Mr. Chairman, Sir, to begin with, I must express my regret, that on this occasion you have behaved exactly as Mr. Shyam Lal Yadav in permitting Mr. Sharma, before you allowed me, to speak (Interruptions)

MR. CHAIRMAN: You represent only 15. He represents so many more.

SHRI PILOO MODY: It does not go by numbers over here. I have been trying to tell you this for a very long time.

MR. CHAIRMAN: If it went by weight, there is another person I should have asked. (Interruptions)

SHRI PILOO MODY: I am very conscious of it. And if it went by brains also, certainly the Opposition will be first. (Interruptitons).

MR. CHAIRMAN: You would have lose on many fronts then.

SHRI PILOO MODY: As I told you earlier, I have no fronts, I am round,

Now, with your permission, I beg to move a vote of congratulations to my friend, Shri Shyam Lal Yadav, on having come and sat with us in spite of being in the bad company of those gentlemen (Interruption) and ladies, yes, I see you, Saroj; well, I never forget you.

Sir, it is a happy occasion whenever an officer of this House is elected there is an election, there is rivalry and a vote ultimately determines as to who should come and sit here. I have no doubt in my mind that my good friend, Shri Shyam Lal Yadav, will continue to be as partisan as he was in the past. But I will only plead with him that now that I have moved closer, I will be able to extend a certain amount of physical control over him, if not moral pressure...

MR. CHAIRMAN: I think something of you may get rubbed off.

SHRI PILOO MODY: I hope a great deal will rub off; my regret is that there is no chair next to you...

MR. CHAIRMAN: I would not sur here then.

SHRI PILOO MODY:...otherwise, the whole procedure of the House would improve considerably.

I also want to take this opportunity of telling Mr. Shyam Lal Yadav that as far as we are concerned, he is the Chair in your absence which is after 12 o' clock. and as long as he is in the Chair, we give him all the respect, affection and cooperation that the Chair is entitled to, and I am sure my good friend, over the years, will mature like good wine. I would also like to thank my good friend, Mr. Dinesh Goswami, who was sporting enough lend his name to our little exercise-the little quarrel which we have been raising with the Government in the manner in which the Deputy Chairman is being chosen and elected. This is something we have protested against yesterday and we continue to protest against. It is a quarrel between the Opposition and the Government. I want to make it quite clear that in this quarrel between the Government and the Opposition, neither Mr. Shyam Lal Yadav nor Mr. Dinesh Goswami is in any way implicated or involved...

MR. CHAIRMAN: It is very nice of you to say that.

SHRI PILOO MODY: Therefore, I want to assure my good friend, neighbour and colleague that I wish him very happy times in the Chair with the least amount of acrimony and warn him that if he does not behave himself, when he returns to this Chair, I will sit on him.

SHRI DINESH GOSWAMI (Assam):
Mr. Chairman, I take this opportunity of
heartily congratulating Mr. Shyam Lal
Yadav on his election as the Deputy Chairman. I also take this opportunity of thanking the various leaders of the Opposition
for proposing my name for the post of
Deputy Chairman. If I agreed to contest
Mr. Shyam Lal Yadav, it is not because
I did not consider him to be fit enough to
hold the post. I have always held him in

high reverence, but because we thought that as a matter of principle the post ought to have gone to the Opposition and in order to establish that principle that I decided to put forward my name for the candidature. Mr. Shyam Lal Yadav has a long record of public service with experience of working in various fields; he has been a legislator of long standing, a Minister of one of the most populous and important States of this country, and also as Deputy Chairman he has conducted the proceedings of this House for the last two years with distinction. I on behalf of myself assure him my fullest cooperation both as a Member and as a Member of the l'anel of Vice-Chairmen, I am sure that under his stewardship the deliberations of House will continue in the best possible manner as they have continued so long. Thank you.

SHRI P. RAMAMURTI (Tamil Nadu): Mr. Chairman, Sir, I also raise my voice in congratulating Shri Shyam Lal Yadav on his elevation to this position of Deputy Chairman of this House. I do not want to mar this occasion by non-serious talk. When I say that I congratulate him, I do it seriously and sincerely. Now, Sir, I wish that this solemn occasion of congratulating Mr. Yaday was not utilised, was not marred by the remark made by Shri Sharmaji when he said that Uttar Pradesh is the most important State in this country. I would like to point out to him that sentiments like this would lead to the disruption of the country. Every State in this country whether small or big is equal and as important as any other State. And I would like to point out to him ...

SHRI A. P. SHARMA: When Mr. Dinesh Goswami said that why did you not object? (Interruptions) He has also said that, see the record.

(Interruptions)

SHRI P. RAMAMURTI: He said 'populous'. He did not say 'important'. Please understand the difference in English language between population and importance. Importance is different from that. Every State in this country, whether big or small, whether populous or non-populous, is equal and important and its importance does not diminish by virtue of its

being less populous. Therefore, Sir, without going into this controversy again. I hope that this kind of sentiments will not be expressed in this House so that the country is preserved. At the same time, Sir, all that I would like to tell Mr. Yadav is that, as Mr. Piloo Mody had told him before, he has got to keep the scales even between the two sides. And particularly, as far the Opposition is concerned, he has got to be a little more considerate because we raise points concerning the common man and we want to arraign the Government, we want the corrections to the Government's policy. Therefore, I hope, would learn the lesson. He has been in many parties. Not only he has been holding many offices but he has been holding in many parites as well, and this experience of being in so many parties also should help him to see that he acts evenly between all these parties. Once again, Sir, I congratulate him.

SHRI J. K. JAIN (Madhya Pradesh): Sir, I am on a point of order. (Interruptions)

SHRI MANUBHAI PATEL (Gujarat): Why do you spoil the atmosphere? (Interruptions)

Sir, I may be permitted. This is not the way. (Interruptions)

MR. CHAIRMAN: No, no. I rule it out. (Interruptions) I rule it out. We must finish this.

SHRI P. RAMAMURTI: If he had said that he comes from Uttar Pradesh, I would never have objected. But only because he has said... (Interruptiton) Do it interrupt me. Because he said Uttar radesh is the most important State in this country, I objected. (Interruptions)

MR. CHAIRMAN: Please sit down.

SHRI NARENDRA SINGH (Uttar Pradesh): Sir, I object to this.

SHRI A. P. SHARMA: Yes, it is,

SHRI MURASOLI MARAN (Tamil Nadu): Mr. Chairman, on behalf of DMK Party, I congratulate Mr. Shyam Yaday on his election as the Deputy Chairman. Sir, we saw a keen rivalry between Mr. Bhishma Narain Singh and Mr. Piloo Mody as to who should congratulate first. It shows Mr. Shyam Lal Yadav's popu larity among all the party Members.

Sir, when Mr. A. P. Sharma referred to UP as the most important State, he had in his mind the fact that UP is the only State which has produced more number of Prime Ministers in this country. But it is wrong. I will tell you why. The present Prime Minister, Mrs. Indira Gandhi, got elected from U.P. and Andhra Pradesh also. But she resigned her from U.P. From that moment, UP ceased to be the most important State.

But, Sir, let us be realistic. What Mr. Sharma said is also true. It is a very populous State. It is sending more representatives to the Lok Sabha and the Sabha. And our House is not like the American Senate where all the States have only two represnetatives. In that he is right. Mr. K. P. S. Menon also said: "India, that is Bharat, that is U.P". This controversy will not arise if, according to Mr. K. P. S. Menon, U.P. is divided into

SHRI PILOO MODY: Four, not two.

SHRI MURASOLI MARAN: I would once again recommend, that suggestion of Mr. K. P. S. Menon should be considered.

Sir, I am particularly glad that one from backward classes and one championing the cause of backward classes has been chosen as the Deputy Chairman. Sir, on behalf of my party, I offer him the fullest cooperation. Thank you.

SHRI B. D. KHOBRAGADE: Sir, I don't mind provocation—provocation from any quarter. I am only expressing my views because I was not present yesterday. I am expressing my views on this point and nothing else because I want that my point of view should go on record. I am with Mr. Dinesh Goswami. There was no voting. Had there been voting, my vote would have gone to Mr. Dinesh Goswami because im principle this post should have gone to the Opposition.

And here is a very important point, Sir. It has been stated by the hon. Mniister—he has spoken on behalf of the ruling

SHRI B. D. KHOBRAGADE: I am not yielding. The hon. Minister has said that U.P. is important. The corollary is that other parts of India are not important. What is the corollary? When one Minister says that U.P. is important, the corollary is that other parts of India are not important.

MR. CHAIRMAN: He has corrected himself. Now, what are you talking, Mr. Khobragade?

SHRI B. D. KHOBRAGADE: This has been the theory in this country.

MR. CHAIRMAN: I htink I must say that it has been said so many times. Now, Mr. Khobragade, to repeat it is in bad taste—if I may say so. It has been said so often. Mr. Advani has said it and Mr. Patel has said it.

SHRI B. D. KHOBRAGADE: The hon. Minister has said so and that is why....

SHRI V. GOPALSAMY (Tamil Nadu): Your party, Sir.

MR. CHAIRMAN: Last word from the judge and then, Mr. Salve.

SHRI P. RAMAMURTI: Last word is from your party.

MR. CHAIRMAN: I have already said the first word.

SHRI B. D. KHOBRAGADE: So, he wants to say the last word from the Justice party.

MR. CHAIRMAN: I will tell him.

SHRI SANKAR PRASAD MITRA: Though I do not belong to any party, I believe as a Member of this House I have a right to offer my hearty congratulations to Mr. Shyam Lal Yadav on his re-election as Deputy Chairman of this House. I have been here only for a short while, and during the time I have been here, I have always found him kind and considerate to all the Members of the House.

I would like to make a humble request to him, Sir. My request is that he should be a little more sympathetic to those who sit in the middle row of this House—who are described as "others." When he rings the bell, he should do so with a little circumspection, particularly when a Member is making some constructive contribution to the debate.

That is the Constitution the people of India have given unto themselves, and a statement of this nature is contrary to the spirit of the Constitution. I would, therefore, request the hon. Minister to gracefully withdraw that statement.

SHRI AJIT KUMAR SHARMA (Assam): I join in the felicitations to hon. Shri Shyam Lal Yadav, and while welcoming him as the Deputy Chairman for the second time, I only wish that from the Chair whenever he looks at the Opposition Members he would forget that he is a Member of the ruling party, the Congress and that whenever he looks at the Members from small States he would forget that he belongs to U.P. I once again congratulate him.

SHRI N. K. P. SALVE (Maharashtra): Sir, it is not a mere observance of convention that on my own behalf and on behalf of my party I offer my felicitations congratulations to Mr. Shyam Lal Yadav on his re-election as Deputy Chairman. Sir, I express our very great delight in joy because in him we have found a man who, while sitting on this Chair, has shown exemplary restraint and impartiality in conducting the proceedings of this House. SHRI N. K. P. SALVE: Only one thing I want to submit. To me and to everyone of our party, for our esteem, our reverence and respect, every State is kept on the same pedestal. If a State is called important, it is not that in our esteem we are keeping it on a higher pedestal but it is just because of its population. And because the person who has been elected happens to come from that State, a tribute is paid in the normal course, and no controversy should have been raised.

SHRI B. D. KHOBRAGADE: The word "important"?

SHRI N. K. P. SALVE: One may say that it could have been couched this way or that way. But so far as the bona fides or the real intent and purpose is concerned, I am sure none of them has any doubt. No one in this House can afford to keep any one State or a higher pedestal than others for esteem, reverence and respect. As for convention and other matters, I do not want to go into it. I submit, Sir, that it is not at all a question of acceptance of one and rejection of the other for this esteemed position. It accords with all that has been happening in this House and there is not the slightest violation of any convention or principle as such. For the first time, I was delighted to hear a speech by Mr. Piloo very responsible Mody. Possibly the fact that he has shifted to that seat has made him responsible because he said: there is no personal rancour, there is no personal bitterness. We have as much goodwill for them as we expect them to have for us. I would only make one request to Shyam Lalji. Kindly do not be led away by the myth that numerically we are very powerful. merically we are not very powerful. They have a galaxy of orators, top-ranking orators. Some of them are such whose names I do not want to take, with such tremendous lung power that against them if there is an operation....(Interruptions)

MR. CHAIRMAN: Before I call upon.....

MR. CHAIRMAN: Before I call upon Shri Shyam Lal Yadav to reply to these words of congratulations, I wish to say that we should now forget once and for all that this happened because of an unfortunate expression, as somebody has put it.

SHRI PILOO MODY: Let him reply first from here.

MR. CHAIRMAN: He will reply. He is already in bad company.

SHRI PILOO MODY: He may be sharing a bench with me, but he is sharing a Chair with you.

MR. CHAIRMAN: I leave it before he sits here, but you promised to sit on him.

श्री उपसंभापति : मान्यवर. में पिछले समय में जब मुझे यह शभ श्रवसर मिला था तो मैंने प्रयास किया कि सदन की कार्यवाही को सदन के नियमों के ग्रनमार ग्रौर सदन की परंपराग्रों के श्रनमार चलाऊं श्रौर जो श्री ग्राडव णी जी ने कहा, वह बात हमेशा मेरे ध्यान में रहती है कि सरकार का कार्य होना चाहिए । लेकिन बिपक्ष के सदस्यों को श्रपनी बात कहने का मौका मिलना , चाहिए । मैं समझता हूं कि उस दायित्व को निभाने में मैं पीछे नहीं रहा श्रीर भागे भी इस बात को मैं विश्वास के साथ कहना चाहता है कि मैं यह प्रयास करूंगा कि मदन की कार्यवाही को नियमों के श्रन्सार चलाऊं और माननीय सदस्यों को श्रपनी भावनात्रों को व्यक्त करने का श्रवसर दू।
