Indo-Japanese trade

- E. 686. SHRI SHYAM SUNDAR MO-HAPATRA: Will the Minister of COMMERCE be pleased to state:
- (a) whether there are possibilities of expansion of trade prospect with Japan; and
- (b) if so, what are the details in this regard?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI P. A. SANGMA): (a) and (b) Yes, Sir. There are possibilities of increasing our exports of traditional as well as non-traditional items to the Japanese market.

Export of rice to East-European countries

SANGMA): (a) to (d) 1981-82 crop of virginia tobacco in Andhra Pradesh has almost been marketed and there are no surplus stocks of virginia tobacco with the farmers. Some complaints from growers for non-payment of dues by the buyers have been received by the Tobacco Board and efforts are being made by the Board to get the payment made to the farmers by the buyers.
