## Live rockets in a coal wagon at Nagaria Sadat Railway station

- 931. SHRI DHULESHWAR MEENA; Will the Minister of RAILWAYS be pleased to state:
- (a) whether it is <sup>a</sup> f<sup>act</sup> that thirteen live rockets were found by the Railway Police on a coal wagon on 15th April, 1982 at Nagaria Sadat Railway statio^, between Bareilly and Moradabad;
- (b) whether it is a^o a fact that the Railway Police on the same day seized 24 longe-range rockets from. a house in Gaya;
- (c) whether any high level investigations had been made into this large scale clandestine theft of such rockets, and if go, the outcome thereof and what action has been taken against the culprits; and
- (d) what measures have been taken or are proposed to be taken to prevent such theft<sub>s</sub> of explosive material during transit particularly in vulnerable areas?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIA-MENTARY AFFAIRS (SHRI MALLIK ARJUN): (a) Yes.

- (b) On 13-4-1982 3 rockets were recovered from a bush near the track, 14 from open wagons in Gaya yard, 6 from an adjacent lane and one from a drain. Subsequently, on 20-4-1982, 4 rockets were recovered from a drain. On 23-4-82 one rocket was recovered from an abandoned well while on 24-4-1982 one rocket could be recovered from a grave yard at Gaya.
- (c) The Government Railway Police, Gaya, Marafari (Bokaro) Police station and Government Railway Police, Bareilly have registered cases No. 0056/82 dated 12-4-82 under section 147/307, 353, 379, 411 IPC and No. 25 A/26 Arms Act and 0102/82

dated 13-4-1982 under section 3/4 Explosive Substance Act and No. 29a under section' 5 Explosive Act dated 15-4-1982 respectively. Police investigations are in progress. G.R.P./ Gaya has arrested one culprit suspecte^ to> be involved in the case of theft of rockets. Of the 56 rockets, stolen, from wagon No. ER-20609, 54 rockets have so far been recovered. The Defence Ministry has also constituted a Court of Enquiry in this connection!.

(d) Arms/ammunition and other explosive materials booked hy the Defence Department are escorted by their own armed personnel whenever necessary during railway transit. At vulnerable areas/yards, however, patrolling is also done by the Railway Protection Force/Railway Protection-. Special Force personnel.
