(b) Expert advice on virreyard management like mode of plantation, training, pruning, manuring and control of pests and diseases is, being given regularly to increase the yield of grapes in the country. It is proposed to raise and propagate planting material of outstanding quality under a Central Sector Scheme.

## Supply of wheat to flour mills

## \*158. SHRI V. GOPALSAMY: SHRI V. VENKA:

Will the Minister of AGRICUL-TURE be pleased to state:

- (a) whether it is a fact that Roller Flour Mills in India are being supplied wheat by the Food Corporation of India;
  - (b) if so, at what price; and
- (c) what is the quantity of wheat that has been supplied to these mills by FCI from 1979 to 1981?

THE MINISTER OF STATE IN THE MINISTRIES OF AGRICULTURE AND RURAL DEVELOPMENT (SHRIR. V. SWAMINATHAN):
(a) Yes, Sir.

- (b) The Central issue price of wheat for supply to Roller Flour Mills is Rs 155 per quintal, fixed with effect from 1st April, 1981, exclusive of local taxes.
- (c) A total quantity of 98,48,000 tonnes of wheat was supplied to the Roller Flour Mills by the Food Corporation of India during the years 1979 to 1981.

## Superannuation of the Chairman and other members of Central Water Commission

Another Member retired from service on the 30th April. 1982.

(b) Suitable action to fill up the vacancies in the above grades has been initiated already and the cases are being processed further on priority basis.
