The estimated loss to the booked as well as railway property, is Rs. 27 lakhs approximately.

- (b) Though no definite cause of this fire has been established the fire appears to be accidental, having perhaps, been caused by a lighted bidi/cigarette thrown inadvertently by some passerby. •! »
- (c) Keeping in view the requirements of fir_e safety arrangements, facilities are being provided/augmented to the extent found feasible and justified.
