THE MINISTER OF STATE IN MINISTRY THE OF HOME AFFAIRS AND DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI P. VENKATA.SUB-BAIAH) : (a) One of the cashiers got himself admitted in the Safdarjung Hospital on the 16th Oct. 1981 and the other cashier got himself admitted on the 17th Oct. 1981. Both were discharged from the Hospital on 17th Oct. 1981 as per the entry in the medico legal certificate.

(b) The complaints have been looked into and are found to be false. The persons concerned were sent to the Police Station, Subzi Mandi, by the Bank Authorities, for interrogation. The Police authorities have denied that they were tortured by the Police.

Council held on 11-10-1977. This along with certain other demands of the Staff Side regarding restructuring of the Central Secretariat Service has been referred to a Committee of the Council. The Committee is yet to submit its report.

.Alleged Uranium Pedlar in Dhanbad
