(b) Number of petitions pending for more than one year as on 31-12-81 is 5561. (c) There is a heavy institution of cases in the Supreme Court and this

has resulted in a backlog. The Sup reme Court has to arrange its work various priorities in keeping view. Occasionally larger benches are consti tuted to hear important constitutional matters.
