THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMEN-TARY AFFAIRS (SHRI MALLIKAR-JUN): (a) Yes.

(b) and (c) Statistics of demurrage charges waived are not maintained commodity-wise in respect of these parties.

Box rakes earmarked for Steel Plants

- 258. SHRI KALRAJ MISHRA: Will the Minister of RAILWAYS be pleased to state:
- (a) whether specific number of box rakes are earmarked for Steel Plants for specific quantity of bulk movement if so, whether it has resulted in better utilisation of wagons and also better goods traffic and better earnings;
- (b) whether there is any proposal under Governments consideration to extend this scheme for carriage of coal, coment, fertilisers and foodgrains, if so, what are the details thereof; and
- (c) if not, what are the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIA-MENTARY AFFAIRS (SHRI MALLI-KARJUN): (a) No.

(b) Does not arise.

(c) If specific rakes are allotted for particular traffic, it will lead to empty haulage in one direction. Hence as far as possible return load is obtained for wagons. Thus wagons going to South loaded with foodgrains being fertiliser from Madras for Northern States.

Manning of level crossing

- (a) how many accidents took place at the un-manned level crossings during the last five year (year-wise) and the number of people killed/injured in these accidents;

- (c) whether Government have drawn any short-term, long-term programme to man the potentially hazardous to safety level crossings, if so, by what time the programme is likely to be implemented and how many unmanned level crossings are likely to be manned as a result thereof?
