## **Discovery of Potash**

- (a) whether it is a fact that Geological Survey of India has conducted research work in Rajasthan and Madhya Pradesh to discover.Potash;
- (b) if so, the total areas (in Sq. Km.) searched by G. S. I. for the above purpose;
- (c) the total quantity of Potash reserve expected to be found there; and
- (d) what are the details in this regard?

THE MINISTER OF STATE IN THE MINISTRIES OF INDUSTRY AND STEEL AND MINES (SHRIMATI RAM DULARI SINHA): (a) and (b) The Geological Survey of India has been conducting investigation for Potash in Western Rajasthan only, ' and not in Madhya Pradesh and has so far covered 20,000 sq kms. for this purpose.

(c) and (<\*) Minor indications of Potash in the form of polyhalites have been noticed in several boreholes. Only recently a rich Potash zone of 50 cms. thickness has been encountered near Ganganagar. Investigations are still in progress and it is premature at this stage to make an estimate of the potash reserve in the area.
