THE MINISTER OF INDUSTRY AND STEEL AND MINES (SHRI NARAYAN DATT TIWARI): (a) and (b) According to a communication received from M/s. WIMCO Limited, the existing differential in excise duty between the mechanised and nonmechanised sectors of match industry has adversely affected their business in matches and consequently, the Madras match factory is closed for an indefinite period. Recently, the above-

mentioned company has approached Government to reduce the excise differential

Hindustan Teleprinters Ltd.

325. SHRI R. MOHANARANGAM: Will the Minister of INDUSTRY be pleased to state:

- . (a) the number of foreign collaboration agreements which the Hindustan Teleprinters Ltd., Madras have entered into so far and the names of products proposed to be manufactured by it;
- (b) whether it is a fact that elec tric typewriters which are being / manufactured by the Company often go for repairs; and
- (c) if so, what steps are being tak en to improve the manufacturing techniques of electric typewriters by I the Company?

THE MINISTER OF INDUSTRY AND STEEL AND MINES (SHRI NARAYAN DATT TIWARI): (a) to (c) Hindustan Teleprinters had entered into foreign collaboration with M/s. Ing. C. Olivetti of Italy in August, 1960 for manufacture of electro-mechanical teleprinters. This agreement expired in December, 1968. Recently, the company entered into another agreement with M/s. Olivetti in October, 1981 for technical collaboration for manufacture of electric typewriters. This agreement is in force. The .company had earlier developed an electric typewriter on their own design and manufactured about 750 nos. during the period 1975-78 to 1978-79 but as there were complaints about the functioning of these typewriters, production has since been discontinued. With the entering into foreign collaboration, the company will be acquiring necessary technical know-how for manufacture of electric typewriters and this will go a long way to improve the manufacturing techniques.
