THE MINISTER OF STATE IN THE MINISTRIES OF EDUCATION AND CULTURE AND SOCIAL WELFARE (SHRIMATI SHEILA KAUL): (a) to (d) The Screening Test for admission to M.D./M.S. courses of Delhi University was held on the 28th February, 1982 and the results were declared on 19-4-1982. Following a decision of the Academic Council to revise the evaluation procedures, some time was taken te completing the process of evaluation. There has, however, been no abnormal delay in the declaration of the results.

- (b) if so, what i_s the number of the Senior post_s of doctors in each of the two hospitals which are lying vacant and since when these post remained unfilled; and
- (c) what are the reasons fo_r not filling up these posts and what steps are contemplated by Government to fill up these vacancies?

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (MISS KUMUDBEN M. JOSHI): (a) to (c) A statement showing posts lying vacant in 'Dr. R. M. L. Hospital and Safdarjang Hospital is placed below as annexure, [See Appendix, Annexure No. 16]. Some of the posts have remained vacant for quite sometime due to several administrative constraints viz. non-availability of suitable officers, delay in convening the D.P.C, meeting of the UPSC on account of restructuring of CHS Rules, etc. Efforts are being made constantly to fill these vacancies on a regular basis in consultation with the UPSC.

JOSHI): (a) t₀ (c) Keeping in view the interests of the students in the five medical colleges, listed below, th_e institutions were granted provisional recognition, on year to year basis, t₀ enable the various deficiencies being removed. The concerned authorities were advised to provide the required facilities as per the recommendations of the Council.

- (1) S. K. Medical College, Muzaffarpur.
 - (2) Nalanda Medical College Patna.
- (3) Magadh Medical College, Gava.
- (4) Patliputra Medical College, Dhanbad.
- (5) Govt. Medical College, Bhagalpur.

After considering the latest inspection -.eports of these colleges, the Executive Committee of Council, at its meeting held in Feb., 1982 have decided not to recommend any further extension of the provisional re- \ cognition of the said institutions, which expires on 30th April. 1982. For the withdrawal oj recognition the procedure as prescribed under Section 19 of the Indian Medical Council Act, 1956 (102 of 1956) has t_0 * be followed.

- (c) whether any person conducting such eye operations has so far been arrested; if so, what are the details in this regard;
- (d) what steps are being taken to bring the crifjSTits to book; and
- (e) what steps are being taken to prevent 'such occurrences?
