**Energising pump Sets in West Bengal**

SAR'NG:

Will the Minister of ENERGY be pleased to state:

(a) the number of pump sets so far energised, districtwise, in West Bengal for agricultural purposes;

(b) the number of pump sets which are not in working order and the steps taken or likely to be taken to repair these pump sets; and

(c) the number of pump sets likely to be energised, district-wise, in West Bengal during 1981-82?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI VIKRAM MAHAJAN): (a) According to the Progress Report made available by the West Bengal State Electricity Board, 24,650 Pumpsets/Tubewells have been energised in the State of West Bengal up to 31.1.1981. District-wise details are given in the Annexure.

(b) Information about the number of pump sets in West Bengal, which are not in working order, is not available. Also, the repairing of these pump sets is the responsibility of the owners.

(c) The Planning Commission has proposed a tentative target of energising 13,140 pumpsets in West Bengal during 1981-82. District-wise details are not available.
