(b) and (c) 11 foreign companies have been granted Industrial Licences and Letters of Intent for manufacture the announcement of the New Drug Drug Policy. These foreign companies hav_e been granted Letters of Intent/ Industrial Licences only for bulk drug_s which involve high teeano-logy and are made from basic value of bulk drug consumption from own manufacture.

Out of the above cases, in one case namely M/s. Bayer (I) Ltd. have been granted a Letter of Intent No. LI:775(80) dated 19th December, 1980 for the manufacture of 2 lakh bottles (20 ml.) of Bayferron, a formulation activity un-connected with manufacture of bulk drug in relaxation of the New Drug Policy, keeping in view the fact that this was a 100 per cent export oriented proposal thereby earning foreign exchange for the country. In another case, a Letter of Intent No. LI: 324(80) dated 26th July, 1980 was granted to M/s. Abbott Labs. (I) Pvt. Ltd. for the manufacture of certain low technology bulk drugs subject to the condition that the Letter of Intent will be converted only after the company dilutes its foreign equity to 40 per cent i.e. at par with Indian companies.
