THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI SAWAISINGH SISODIA): (a) Sir. A Custom Clearance Permit (without Exchange Control Copy) No. P/J/3060194 dated 12-2-1981 was issued by the Chief Controller of Imports, and Exports, New Delhi, in favour of Swami Dhirendra Brahmachari, Aparna Ashram, for the import of one No. "Cssna P-337 Skymaster Aeroplane. with spares', valued at Rs. 28 lakhs. This Customs Clearance Permit was issued on the basis of a letter dated 10-9-1980 signed by Mr. Swaraj Paul, U.K., confirming that the aircraft had been offered as a gift.

(b) Customs duty amounting to Rs. 3,23,842-15 was charged on the said aeroplane on its importation. The duty was correctly charged at the rate which is applicable to aeroplanes whether received as a gift or otherwise.

Foreign Collaboration for Pelletisation Plant at Mangalore

1219. SHRIMATI MONIKA DAS: Will the Minister of STEEL AND MINES be pleased to state:

- (a) whether Government have sought foreign collaboration for the setting up of a pelletisation plant at Bangalore in Karnataka; and
- (b) if so, what are the ditails in this regard?

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) Yes, Sir.

(b) The patented process know-how of pelletising iron ore is held by a few foreign firms only. Kuaramukh Iron Ore Company Limited had, therefore, invited tenders on a limited global

basis for construction of the Mangalore pellet plant. Tenders were received in response thereof from five parties, viz., M/s. Lurgi Chemie, M/s. Allis Chalmers, M/s. Voest Alpine, M/s. Uzine exportimport and M/s. Met. Chem., Canada. After evaluation of the tenders, detailed negotiations have been held with the parties. The matter is now in the final stage of consideration by the Company.

- (b) The Central Bureau of Investigation made three references to National Criminal Bureau, Rome and one to National Criminal Bureau, Kuwait.
- (c) Reports to the references have been received from National Criminal Bureau, Rome. The results of enquiries from National Criminal Bureau, Kuwait are awaiated and they have been reminded to expedite the same.
- (d) The case is not pending as it could be finalised on the basis of the report received from Rome.
- (e) On receipt of the report from National Criminal Bureau, Rome,

investigation by the Central Bureau of Investigation in the case has been finalised and a complaint has been filed in the Court of Additional Chief Metropolitan Magistrate, Bombay on 16-4-1981, against M/s. Bisleri (India) Private Limited and its two directors, namely, S/Shri Ramesh Chauhan and H. M. Golwala, for offences under section 120 B IPC read with section 420 IPC and section 23(1-A) of Foreign Exchange Regulation Act, 1947 (cor responding to section 56 of Foreign Exchange Regulation Act, 1973) and section 23(1-A) of Foreign Exchange Regulation Act, 1947 (corresponding to section 56 of Foreign Exchange Regulation Act, 1973) read with section 22 and 23-C of Foreign Exchange Regulation Act, 1947.
