India are of the view that on the west side of Parliament Street, the height of the building may be as high as the existing building of the Allahabad Bank. The matter is still under consideration of the Delhi Urban Arts Commission in the light of the views expressed by the Archaeological Survey of India

Allotment of House for Employees belonging to SC/ST

1439. SHRI PANDURANG DHARMAJI JADHAV: Will the Minister of WORKS AND HOUSING be pleased to state:

THE MINISTER OF PARLIAMEN TARY AFFAIRS AND WORKS AND HOUSING (SHRI BHISHMA NARAIN SINGH): (a) Yes, Sir. Special provision has been made for allotment of residential accommodation t₀ Government employees belonging t₀ Scheduled Castes/Scheduled Tribes.

(b) The information is as under:

(c) No, Sir. Reservation in accommodation has been made keeping in view the relative percentage of satisfaction in various categories and the availability in each category.

S. C. and S- T. Employees in Hyderabad University

1440. SHRI PANDURANG DHARMAJI JADHAV: Will the Minister of EDUCATION be pleased to state:

- (a) whether it is a fact thaT; a meeting of the Consultative Committee of the Ministry of Education was held at Hyderabad in January last:
- (b) whether the said Committee also visited Hyderabad University to acquaint itself with the different courses and the students and teachers ratio;

- (c) whether it is a fact that the ratio of the student and the teaching staff in the University is 1:1, and there are no Harijan and Adivasi employees; if so, whether it is justifiable;
- (d) whether Government propose to hold an enquiry regarding the numoer of Scheduled Castes/Tribes employees on the staff of the university; and
- (e) if :;o, what steps Government propose to take for recruiting the Scheduled Castes/Tribes candidates?

THE MINISTER OF EDUCATION AND SOCIAL WELFARE (SHRI S. 3. CHAVAN): (a) Yes, Sir.

(b) The Committee, during its short visit to the new campus of the University, was taken around various departments, workshops etc.

- (c) According to the information furnished by the University, teacher-students-ratio is 1:5 and not 1:1. Further, there are 59 employees belonging to Scheduled Castes and 6 belonging to Scheduled Tribes amongst the non-teaching staff, O_n the teaching staff, no Scheduled Castes/Scheduled Tribes candidates were appointed as there were no applicants from Harijans/ Adivasis who fulfilled the prescribed qualifications.
- (d) and (e) The University is aware of the University Grants Commission/ Government guidelines in the matter of reservation for various posts. The University has also reported that efforts are being made to increase the number of Scheduled Castes/Scheduled Tribes personnel. The question of holding an enquiry does not arise.

Assistance given by PADI for Gonda Project

• *XJ.P.* made by the Deen Dayal Research Institute, New Delhi, of which Shri Nanaji Deshmukh is the Chairman, was approved for assistance by PADI in June, 1978. In 1978-79 Rs. 11.80 lakhs was advanced to the Institute for this project. No funds were given in 1977-78 and 1979-80.

(c) This project has been financed out of funds available with PADI from the sale proceeds of fertilisers donated by Misereor, West Germany. These funds were placed at the disposal of PADI to finance agriculture development projects.
