(b) if so, what steps Government have taken in this regard to improve the conditions?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR (SHRIMATI RAM DULARI SINHA): (a) Yes, Sir.

(b) The article refers to various shortcomings in the ESI dispensaries/ hospital in Delhi. The major improvements reported in this regard are as follows:

### (i) Shortage of Medical Officers.

170 out of 200 doctors are in position. Selection of candidates for the remaining 30 posts have since been made and these posts are likely to be filled up shortly. However, in order that the work in dispensaries does not suffer, the Corporation has been making ad-hoc arrangements against vacant posts on short term basis.

(ii) Shortage of accommodation in Dispensaries.

7 out of 27 dispensaries in Delhi are functioning in the Corporation's own building and rest of the dispensaries are located in rented buildings. The Corporation has recently acquired one plot in Mangolpuri area, for construction of a dispensary. Another four plots at Nand Nagri. Seclampur, Inder Lok and Raghubir Nagar are in the process of being acquired. The DDA has been requested to allot suitable plots for construction of 13 more dispensaries in different areas.

(iii) Shortage of accommodation in ESI Hospital Delhi.

The Corporation has sanctioned construction of an additional block with 250 beds in the ESI Hospital, Basaidarapur. They have also acquired eight acres of land from DDA in Jhilmil area (Trans Yamuna) for construction of a second ESI Hospital with 200 beds.

(iv) Shortage of equipment and drugs in dispensaries.

All the dispensaries have been provided with basic equipment, in-cluding refrigerators, required by them. The supply of drugs is adequate.

#### Seminar on Territorial Waters

THE MINISTER OF STATE IN THE DEPARTMENTS OF SCIENCE AND TECHNOLOGY AND ELECTRONICS AND ENVIRONMENT (SHRI C. P. N. SINGH): (a) One of the recommendations of the ocean futures workshop held in March, 1981 at Goa was to extend the outer limit of territorial waters beyond 12 miles. Government, however, has no such proposal under consideration.

(b) No Sir.
