T.B. Eradication Programme

1827. SHRI KALPNATH RAI: Will the Minister of HEALTH be pleased to state:

- (a) whether it is a fact that the TB Association of India has reported that the case finding activity in rural areas is woefully deficient;
- (b) whether it is a fact that the National T.B. Programme introduced several years ago is yet to reach 70 districts;
- (c) whether it is also a fact that in the areas where the programme has been implemented, the infra and super structures are weak; and
- (d) if so, what action is being taken to cover the whole of India and strengthen the infra and super structures for proper implementation of the programme?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI NIHAR RANJAN LASKAR): (a) Yes.

- (b) No, it is not so.
- (c) No.
- (d) Does not arise. It may, however, be added that the State Governments are being advised to take up establishment of District TB Centres in the left out districts of their States and add more TB beds where necessary.

Award of degrees of Bims

(a) wether it is a fact that the Delhi Administration have not awarded degrees to the successful candidates of Bachelor of India Medicine and

Surgery of the Hamdard Tibbi College, Delhi, for the past many yeras; and

(b) if so, since when the degrees have not been awarded and what are the reasons therefor?

Ad-hoc promotions of Senior Punch Verifier Operators in the Railway Board

1829. SHRI M. MOSES: Will the Minister of RAILWAYS be pleased to state:

- (a) whether it is a fact that Senior Punch Verifier Operators in the pay scale of Rs: 330-560 have been allowed jumping of the grade of Rs. 425-640 and granted grade pay in the scale of Rs. 550—750 on their ad-hoc promotion to the ex-cadre post of Console Operators in Computer Centre in the Railway Board irrespective of the fact that they are neither eligible nor empanelled for that post;
- (b) whether it is also a fact that the present incumbent of the excadre post of Technical Assistant in Finance (LN) Branch in the Railway Board who has since been empanelled, has not been allowed grade pay of the post in the scale of Rs. 700—900 on his ad-hoc promotion; and
- (c) if answers to parts (a) and (b) above be in the affirmative, what are the reasons for such discrimination?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) Yes, in a few cases, ad-hoc promotions are being made in exigencies of service.

- (b) Yes. However, it has since been decided to grant him grade pay from the date of notification of the relevant panel.
- (c) The two cases quoted in parts (a) and (b) above are not comparable.

Conversion of Darbhanga— Jayanagar (NER) M. G. Line into Broad Gauge

found viable the project would be undertaken for construction subject to clearance and allotment of funds by the Planning Commission.

Water Supply at the Madhubani Railway Station

- (a) whether it is a fact that the water supply arrangement independent of the municipality has been made at the Madhubani (NER) Railway Station;
