Letter of Intent, the question of verification of compliance with these conditions at the time of recommending conversion of the Letters of Intent does not arise.

(b) At present no Letters of Intent or Industrial Licences are being issued to the foreign companies for drug formulations alone except in wholly export oriented proposals. Permission to make formulations is given only to those companies which are granted Letters of Intent or Industrial Licences for bulk drugs. This is further subject to the maintenance of the ratio of 1:5 between the value of production of bulk drugs and that of the formulations. Since the permission to formulate is now granted only as part of the company's own bulk drug production, it cannot make the present bulk drug to formulation ratio worse than that already existing.

After the announcement of the new Drug Policy only one foreign company viz. M/s. Bayer (India) Ltd. have been granted a Letter of Intent for the manufacture of a formulation alone viz. Bayferron in relaxation of the existing policy. This was because it was a 100 per cent export oriented proposal.
