(c) and (d) In view of the fact that a large number of applicants for cooking gas connections are still on the waiting lists, it is presently not possible to make available cooking gas on demand in metropolitan cities.

(e) It is not possible to assess the exact demand of LPG (Cooking gas) in the country as other alternate fuels like kerosene, soft coke, fir© wood and gobar gas are being used. About 4.3 lakh tonnes of LPG (Cooking gas) is available in the country which meets the demand of about 32 lakh cooking gas consumers.

(a) whether it is a fact that a number of foreign companies short-listed for oil exploration in the selected blocks in the country had come to India;

(b) if so, what are the names of the companies in the blocks proposed to be given to them;

(c) whether these companies have submitted their final bids;

(d) if so, what are the details thereof; and

(e) what are the details of the agreement finalised or propped to be finalised with these companies?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI P. C. SETHI): (a) Yes, Sir. Twentyone companie<sub>s</sub> out of the thirtyfive short-listed companies had visited ONGC, Dehradun, for technical discussions.

(b) to (e) No bids have been received so far nor have any agreements been finalised yet. Government has invited twenty four foreign companies who had shown continued interests for submitting their offers by 30th April, 1981 i<sub>n</sub> respect of the 32 blocks on offer for exploration contracts.
