Loss suffered by National Textile Corporation

661. SHRI PRAKASH MEHROTRA: Will the Minister of COMMERCE be pleased to state:

(a) whether it is a fact that the National Textile Corporation suffered a loss of about Rs. 5 crores during the last financial year as a result of failure of Railways to supply wagons for transporting coal to the Corporation's textile mills; and

(b) if so what steps Government have taken to remedy the situation?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI KHURSHED ALAM KHAN): (a) During 1980-81, the National Textile Corporation is estimated to have suffered a loss of Rs. 3.90 crores. Inadequate supply of railway wagons is also one of the conitributory factors to this situation.

(b) Railway authorities have since taken steps to accelerate the pace of movement of coal to the textile mills, including NTC mills during the current year.
