## Enhancement of cement quota for Karnataka

991. SHRI M. BASAVARAJU: Will the Minister of INDUSTRY be pleased to state:

- (a) whether Government of Karnalaka has requested the Central Government to enhance cement from 2.25 lakh metric tonnes to 3.25 lakh metric tonnes per quarter;
- (b) whether the State Minister for Food and Civil Supplies met him for the same purpose in the recent past;
- (c) whether Government have taken any decision on the request;
- (d) if so, what are the details thereof?

THE M NISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI CHARANJIT CHANANA): (a) (d). Yes, Sir. The Government of Karnataka have requested that quarterly allocation may be raised from 2.08 lakh tonnes to 4.00 lakh tonnes. There is a general scarcity of cement in the country including Karnataka. The Government are making every effort to increase availability of cement in the country by way of better utilisation of existing capacities, sanctioning new capacities and imports. Enhanced allocation to the States including Karnataka will be possible only when the availability position of cement in the country improves. However, having regard to the requirements of the State quarterly allocation was increased from 1.98 lakh tonnes to 2.08 lakh tonnes of cement from quarters July-September, 1980. Further additional allocations of 42,000 tonnes and 40,000 tonnes have been made to the State Government during

quarter i.e. Januarythe first March, 1981 and second quarter i.e. April-June, 1981 respectively.

### Anti-dacoit operations in States

THE MINISTER OF STATE IN THE MINISTRY OF HOME **AFFAIRS** MAKWANA): (SHRI YOGENDRA (a) to (c). Requests have been received from the Governments of Madhya Pradesh and Uttar Pradesh for assistance from the Defence Ministry for certain vehicles, weapons and equipment. It would not be in public interest to disclose their de-Government of India would tails take appropriate action in consultation with the two State Governments.

The Government have provided Central financial assistance amounting to Rs. 750.00 lakhs to all the State Governments, including Madhya Pradesh, Uttar Pradesh and Rajasthan, for modernisation of their State Police Forces during 1980-81. A provision of Rs. 10 crores has also been made for 1981-82. The Central assistance is intended to meet expenditure of a non-recurring nature for purchase of vehicles, wireless equipment, computers, scientific aid for investigation and training equipment. This Central assistance could be utilised by the State for modernising their Governments Police Forces also for anti-dacoity operation.
