The DDA has also stated that it has decided to allot staff quarters to the Slum Department employees. The DDA Slum Employees Union have however submitted a Memorandum interalia raising the issue relating to HRA, medical facilities and staff quarters. The matter has referred to Delhi Administration for their comments.
