(d) The accounts are required to be audited by the internal auditors and approved by the General Body of the Association before submission to the Government. These are scrutinised by the Government before releasing the grant for the next year.

In case the association is not able to utilise the grant-in-aid in full, the un-utilised amount is taken into account at the time of release of grant-in-aid for the next financial year.

## Retirement age of Class IV Employees

1532. SHRI SWAMI DINESH CHANDRA: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether it is a fact that retirement age of all class IV Central Government employees ig 60 years; and
- (b) whether it is also a fact that option is asked from the class IV employees before they are promoted to grades which will debar him from for which posts the age of retirement is 53; and
- (c) whether it is also a fact that these class IV employees who refuse to accept promotion and are promoted by the Departments concerned unilaterally are not put to a disadvantage by retiring them earlier than their original date of retirement?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI P. VENKATASUBBAIAH): (a) Yes, Sir, except in the case of class IV employees of the Secretariat Security Force, who enter service on or after 15-9-1969 for whom the retirement age is 58 years.

- (b) No, Sir. It is open to an employee to refuse promotion to higher grade which will debar him from asking for promotion for a specified period.
- (c) The Department of Personnel and Administrative Reforms has no information regarding the alleged unilateral promotion of Group 'D' employees who desire to continue as Group 'D'. As stated above, an em-

ployee is free to refuse promotion to higher grades if he wants to continue as a Group 'D' employee.

## Changes in Police and Intelligence set up

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether a sum of Rs. 100 crores is proposed to be spent to revamp central police and intelligence units;
- (b) if so, what are the nature of changes sought to be brought about to modernise intelligence units; and
- (c) what steps have so far been taken by Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI YOĞENDRA MAKWANA): (a) No, Sir.

(b) and (c) Modernisation of the Police force including Central Police and Intelligence units is a continuous process. Steps are taken from time to time to revamp the police force by upgrading police skills and equipment.
