

Working conditions of Hindi Officers Translators in Central Ministries

1516. SHRI B. IBRAHIM: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that his Ministry issued any instructions to all Ministries/Departments that the officers working on deputation/ad-hoc basis on the post of Hindi Officers| Translators may not be reverted pending the formation of CSOL Service or till 31st December, 1981; and

(b) if so, what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI YOGENDRA MAKWANA):

(a) and (b) Yes, Sir. Instructions have been issued that such persons as are working on deputation/ad-hoc basis against posts being included in the proposed Central Secretariat Official Language Service and whose services are found satisfactory, may be allowed, where necessary, with the concurrence of the Union Public Service Commission, to be retained in their respective posts till the formation of the Service or 31st December, 1981, whichever is earlier. They may not be reverted to their parent office| substantive posts merely because their period of deputation has expired.

Gun Battle between two factions of underground Nagas

1517. SHRI N. P. CHENGALRAYA NAIDU: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that two faction of the underground Nagas were involved in a gun battle which was joined by the Burmese Security Forces at Ayiching in Northern Burma, opposite the Tuensang district of Nagaland on the 17th July, 1981; and

(b) if so, what are the details of the incident?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI YOGENDRA MAKWANA): (a) and (b) Since the incident referred to had occurred in a foreign country the Government is not in a position to give the details.

Peace talks between the Centre and M.N.F.

1518. SHRI N. P. CHENGALRAYA NAIDU: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that *divisive forces* were recently active in Mizoram using student power to subvert the peace talks between the Centre and the Mizo National Front and to propagate their ideology; and

(b) if so, what is the reaction of Government of India thereto?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI YOGENDRA MAKWANA):

(a) and (b) No such activities have come to Government's notice.

Burning of Harijan Colony in Tamil Nadu

1519. SHRI PATITPABAN PRADHAN: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether Government's attention has been drawn to the press report appearing in the 'Statesman' dated the 11th August, 1981 regarding burning of a Harijan Colony at Tholar near Pennadam in Tamil Nadu; and

(b) if so, what is Government's reaction with regard thereto?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI YOGENDRA MAKWANA):

(a) Yes, Sir.

(b) According to the information received from the State Government of Tamil Nadu, on 29th July, 1981, at about 08.00 hours, one Harijan youth teased the caste Hindu girls and ill-feeling arose between the Caste Hindus and the Harijans. Between 30th July, and 3rd August, 1981, in-
