- (b) if so, whether any discussion was held with the Government of Kerala for the construction of Link-Road; and
- (c) what decision has been taken in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI BUTA SINGH): (a) to (c) Presumably, the Member is referring to the Link Road Cochin Byepass of National Highway No. 47 to Cochin Port in Willingdon Island. The project estimated to cost R_{S} 669 After discussions with State Govvernment, and Cochin Port Authorities, the Govt. of India have already agreed to share 1/3rd cost of this work, the balance cost being shared equally by the Cochin Port Trust and Kerala Government.

Presence of Naval strength in Indian Ocean

2317 SHRI SYED SHAHABUDDIN: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) the latest estimate of great powers naval presence in the Indian ocean, both mobile and static, seabased and land-based;
- (b) whether there is any indication of abnormal naval concentration in the Arabian Sea in recent months;
 - (c) whether the airfield in Diego Garcia is being upgraded to take B-52's;
 - (d) whether there is any indication of the deployment of nuclear weapons and nuclear-powered submarines in the Indian Ocean; and
 - (e) which countries in the littoral have provided shore facilities, temporary or permanent, exclusive or otherwise, to the naval vessels of the great powers?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO): (a) It would not be in the public interest to reveal precise infor-

mation on Great Power naval presence in the Indian Ocean area.

- (b) Yes, Sir.
- (c) It is understood that B-52 aircraft can operate from Diego Garcia.
- (d) It is understood that nuclear powered submarines are being deployed in the Indian Ocean area. It is likely that nuclear weapons have been deployed in the Indian Ocean though Government do not have conclusive evidence to this effect.
- (e) In addition to the US base at Diego Garcia, it is understood that the U.S.A. has access to facilities in Kenya, Somalia, Oman and Australia; and the USSR to facilities in Ethiopia and the People's Republic of Yemen. Some other countries also provide non-exclusive facilities to naval vessel3 of third countries.

Cost of Handling Container at Madras Port

2318 SHRI M. S. RAMACHAND-RAN: Will the Minister of SHIPPING AND TRANSPORT be pleased to state:

- (a) whether it is fact that cost of handling containers is costlier at Madras Harbour than at Bombay and Cochin:
- (b) whether it is also a fact that lesser number of workmen are employed for stuffing and destuffing containers at Madras Harbour in comparison with the workmen employed at Bombay and Cochin; and
- (c) if so, what are the reasons therefor?

THE MINISTER OF SHIPPING AND TRANSPORT (SHRI VEERENDRA PATIL): (a) It is not correct to say that the cost of handling container is higher at Madras than at Bombay. However, the cost of handling containers is higher at Madras than at Cochin.

(b) Yes.

(c) The number of workers required for handling containers is being determined by Ports, taking into consideration local conditions and labour arrangements.

Offer for Establishment of shorebased institution

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIA-

MENTARY AFFAIRS (SHRI MAL-LIKARJUN). (a) There are no instructions to permit loading of BCX and CRT wagons, which comprise Jumbo freight trains, by extra five tonnes above carrying capacity. Present instructions permit loading of these wagons up to carrying capacity plus two tonnes only. The whole train does not constitute a load beyond the capacity of diesel and electric locos.

(b) to (d) Do not arise.
