Finance Ministries are negotiating for leasing out blocks for offsnore exploration are insisting on a major departure from the guidelines laid down by Government in its circular to all the short-listed companies before they could consider entering into an agreement:

- (b) if so, whether one of the guideline is that all the foreign companies should at the end of five years afterdiscovery and production of oil hand over all operations to the oil and natural gas commission;
- (c) whether it is also a fact that some of the foreign firms have opposed their time limit; and
- (d) whether Government has agreed to give some concession in this regard?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI P. C. SETHI); (a) to (d) Negotiations are in progress with foreign oil companies. It will not be in public interest to disclose any thing further at this stage.

## Exploration for oil in coastal areas

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI P. C. SETHI): (a) Yes, Sir.

Year Plan 1980—85 two more contract seismic parties apart from ONGC's own seismic survey ship 'MV Anveshak', are planned for deployment to cover the Eastern and Western continental shelf and slope areas by seismic surveys. 95 Exploratory wells involving a total metreage of 275,000m involving 22.8 rig years are planned to be drilled in the offshore areas for exploration purposes.

## Functioning of Sangii All India Radio
