Will the Minister of PETROLEUM, CHEMICALS AND FERTILIZERS be pleased to state:

- (a) whether Goernment have received any complaint about the shortage of essential drugs in the country and especially in Kanyakumari District of Tamil Nadu; and
- (b) if so, what are the details thereof and what steps Government propose to take to make such drugs available?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI P. C. SETHI): (a) and (b) Government monitors the availability of life-saving and essential drugs on the basis of reports received from the State Drug Controllers, Zonal Offices of the Central Drugs Standard Control Organisation and public complaints.

Shortages of specific brands of some essential and life-saving drugs have been reported from time to time from different places in the country; but the Government have not received any reports of shortages of such drugs in Kanyakumari District of Tamil Nadu in the recent past.

The shortage reports for the week ending 5-9-1981, included those of-Chlorostrep Capsules/Suspension, and Chloromycetin Capsules (Parke Davis); Penidure L.A. (John Wyeth): Idifulvin Tablets (IDPL); Adelphane Esidrex and Adelphane Esidrex & Adelphane Tablets (Ciba-Geigy); PAS Granules (Pfizer); Dapsone Tablets Wellcome); (Burroughs and Brinerdin Tablets (Cyanamid); tablets (Sandoz). Equivalent products are available for most of these drugs.

As soon as shortage of a drug is noticed in any region, the manufacturer of the concerned product as well as the manufacturers of the equivalent products are advised to rush supplies to the area concerned. To prevent shortages, the Government arranges

imports of such drugs which may be in short supply in the country. It also makes special allocations of canalised drugs to manufacturers from the CPC when required to improve the availability of essential and life-saving drugs.

## Doordarshan Centre in Assam
