(c) A tourist circuit comprising Bodhgaya, Nalanda and Rajgir has been identified for development in the State of Bihar.

(d) It has been decided to establish four new hotel management institutions in the States, which do not have any hotel management institutions supported by Ministry of Tourism, at present. An Institute of Hotel Management is already functioning at Hazipur in Bihar. There is no proposal from the State Govt, of Bihar to set up another Institute of Hotel Management in Bihar.
