तथा थिकें इस्पात बनाने के बदले कच्चा लोहा बनाने के लिए अधिक मात्रा में तप्त आतु दी गई थी। चालू वित्त वर्ष में सार्वजनिक स्रोतों में बिजली की आपूर्ति में सुधार हो जाने से विकेय इस्पात का अधिक उत्पादन करना सममय ही सका है।

(ख) से (घ) वर्ष 1981-82 की धर्तमान ग्रायाः नंति में यन्चे लेहे की सभी श्रेणियों का ग्रायात स्टील ग्रथारिटी ग्राफ इंडिया लिमिटेड (सेल) की मार्फत करने की व्यवस्था है। ग्रायात नीति में यह परिवर्तन 4 सितम्बर, 1981 से किया गया है इससे पहले कच्चे लोहे का ग्रायात खुले सामान्य लाइसेंस के ग्रन्तगंत किया जाता था। चालू वित्त वर्ष में वास्तव में कच्चे लोहे की कितनी मात्रा का ग्रायात किया जायेगा यह मुख्य उत्पादकों के उत्पादन तथा वास्तविक उपभोक्ताग्रों द्वारा ग्रायात की जाने वाली सामग्री की मात्रा के पंजीकरण पर निर्भर करेगा।

Indians Employed under World Bank and International Monetary Fund

2609. SHRI SHIVA CHANDRA JHA: Will the Minister of FINANCE be pleased to state:

- (a) how many Indians have worked in the World Bank and the International Monetary Fund Organizations uptill now and what are their names;
- (b) how many Indians are working at present in one capacity or the other in these organisations; and
- (c) how many of those Indians working at present had worked in India before joining those services and what are their names?

THE MINISTER OF FINANCE (SHRI R. VENKATARAMAN): (a) to (c). The World Bank and the International Monetary Fund have been in existence for over 30 years. During that period Indian nationals have been employed by them at various levels

ranging from the clerical to the professional. Such employment has ranged from short-term consultancies to regular appointments, There is no obligation for these agencies to consult or obtain clearance from the Government of India before employing private Indian citizens and as such information on all Indian nationals who have been employed so far is not available.

As regards persons employed from Government service and public sector, information is being collected and will be placed on the Table of the House when ready.

Import of Elephants

2610. SHRI SHIVA CHANDRA JHA: Will the Minister of COM-MERCE be pleased to state:

- (a) whether India imports elephants from African countries and Sri Lanka;
- (b) if so, what are the details thereof; and
- (c) if not, what is the number of elephants exported or imported during the last three years?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI KHURSHED ALAM KHAN):

(a) to (c). There has been no import of elephants during the period from 1-4-1977 to 30th June 1980, upto which date import data is available. During the same period, 19 elephants were exported, comprising 12 during 1977-78 and 7 during 1979-80.
