tonnes to Pakistan over the last three years was perfectly legal and conformed with the International Atomic Energy Regulations". It would therefore appear that Pakistan was directly supplied 110 tonnes of uranium yellow cake by the Niger Government. As regards the financing of Pakistan's nuclear programme, Governments of Pakistan an[^] Libya have both denied that there is cooperation between them in the nuclear field.

Government oj- Pakistan have given us assurances that their programme is geared towards peaceful purposes and has no nonpeaceful dimensions. It is hoped that the Government of Pakistan will abide by its assurances.
