- (b) Efforts are being made to intensify our exploration activities and for greater exploitation of our established reserves. Also efforts are being made to promote conservation measures and to restrict the demand of oil by suitable measures. These will yield results only over a longer term.
  - (c) Yes, Sir.
- (d) We have also to exploit coal and other available sources of energy.
